ARTIST COMMITMENT

The Trails and Trees Studio Tour of Berkeley County supports artists in our community by providing a professional and inviting local venue. As participating members of the Tour, we support each other and work together to organize and operate the event. Artists are counted on to volunteer with all aspects of the event to ensure a successful showing for all involved.

QUALIFICATIONS FOR ENTRY INTO THE STUDIO TOUR:

1. Participating artists assure that all work is original, displays excellent craftsmanship and portrays the "hand and spirit" of the artist.
2. The artist must be thoroughly involved with the design and production of each article with the exception of those works of original design that require out of studio production/reproduction, such as prints/reprints/castings, all of which must be made from the artist's original work.
3. Work/product and studio space must meet approval by the Tour Review Committee. The Review Committee must be notified of any major changes in studio product or studio space/location.
4. The Studio Tour is open to artists who reside in and/or have creative space in Berkeley County, WV (includes the 25427 zip code area). From time to time Guest Artists, who reside outside of the area may be invited to participate at the discretion of the Steering Committee and the Tour Review Committee.

PARTICIPATING ARTISTS:

1. Assure that all work shown on the Tour meets the qualifications for entry.
2. Upon acceptance into the Tour, pay the \$150 annual Tour participation fee (due on April 15th preceding Tour date) on time and submit all required forms and photos. Application fee is non-refundable.
2. Must be present during the Tour at their studio location. A designated substitute may be permitted with advance notice.
4. All artists are expected to participate in the production and promotion of the Tour.
5. Artists are responsible for providing their own insurance (for site and artwork) and acquiring required local permits and licenses.
6. Artists who do not abide by the above requirements related to the Tour participation or their artwork as stated or who act in a manner detrimental to the spirit of the Tour as determined by the Steering Committee may be asked to leave the Tour.
8. Artists who have outstanding financial obligations to the Tour may be barred from participating in the Tour until the obligations are cleared or as determined by the Steering Committee.
